## **Technician Training Conducted**

Fourteen (14) students attended an Amateur Radio Technician License class sponsored by TARS on Saturday, September 25, 2010. The class ran from 9:00 AM to 4:00 PM at St. Francis Episcopal Church. There was no charge for the class.



The course covered the necessary FCC rules & regulations, electronic theory, and operating practice for the FCC Technician Class Amateur Radio License. The class was taught primarily by Phil Ashler, N4IPH, with several other hams assisting.

There is a \$15 non-refundable examination fee that is payable to the

ARRL for the administration of the test. Please bring your checkbook to the testing session, along with two forms of identification, with at least one being a photo ID.

## **Simulated Emergency Test (SET)**

The Capital District ARES will participate in the national Simulated Emergency Test (SET) on October 2, 2010. The test is intended to test our capabilities to respond as a district and as counties should an emergency hit the Big Bend area.

This year, the North Florida Section, working with the Alabama and Georgia sections will experience a major hurricane hitting the Florida panhandle. Working with the Tallahassee National Weather Service (NWS), the exercise will begin the week before the test starts with realistic bulletins announcing the storm and then tracking it as it moves into the Gulf of Mexico and ashore.

The Capital District will respond to activation calls by deploying its Jump Team under the leadership of Chuck, Al4KA, to the coast on Saturday October 2, to make tide, wind, and wave observations, which will then forward their report to the WX4TAE, the NWS amateur radio station. At the same time Dan Moniz, Kl4HGO, the Capital District Emergency

Coordinator, acting according to the North Florida Section's plan, will activate the Capital District. VHF and HF nets will be opened at 9 a.m. on the 146.655 MHz repeater and on 3.960 MHz. In addition, teams will be deployed to the two local hospitals, the Red Cross Headquarters station and shelter stations will be activated. Communications will also be established with the State Emergency Operations Center, County EOCs, and the Alabama and Georgia EOCs. Besides these voice nets, the Capital District will pass traffic using D-STAR. WinLink, PSK-31, Packet, and APRS. In particular, we will see if we can use the FEMA message form, ICS 213, to send traffic over amateur radio.

This will be an extensive test of our capabilities, and we can use as many amateurs as are able to help. The exercise will nominally last from 9 a.m. until 4 p.m., and if you can help for an hour or longer your participation would be greatly appreciated. If you can help, please contact your county emergency coordinator or send Dave, WA4WES, an email (davedavis1@embarqmail.com) indicating you can help. If past experience is any indicator, this will be an interesting and fun time. I hope to hear from you.

## SE Division ARRL Directors to be Elected

There are 15 directors in the league and these positions steer the league in the direction it travels by the way they vote. Every year there are five (5) elections somewhere in the ARRL directorship and this fall the SE Division is one that is up for the vote.

The Division directors are the only voting members of the board. The Director is your link to the board and is a very important part of the organization.

This position requires being in touch with the membership, posting information from the ARRL to the membership and your input along with others is to be considered in any voting. Most agenda items with 8 or more votes will pass that item being considered.

The Vice Director is a non voting member and attends the board meetings as a team member who if necessary would step up and become the voting member.

This position requires being in touch with the membership, staying current on issues and assisting the Director in the operation of the division.

While these are basic descriptions of these positions, please check the ARRL web pages for detailed information concerning these and other positions. Ballots will be sent out to all ARRL members October 1st, 2010 and must be returned to league head quarters in mid November.

To be eligible to vote, you must be a current ARRL member.

There is approximately 60 days until the deadline for ballots to be into the league. With this in mind, visit the candidate web sites, call them, email them and/or challenge them to find out how they will represent you if they are elected to the positions they seek. There are three (3) hamfest before the final votes have to be in and if possible visit a hamfest and talk to these people in person. While each candidate will use a variety of mediums and media to get your vote, nothing will beat a direct contact to inform you which way to vote.

#### INTRODUCTION OF GUESTS

Dan Moniz KI4HGO welcomed John Elzie a new visitor.

Dan introduced Tallahassee's Chief of Police Dennis Jones. Chief Dennis M. Jones became the 14th Chief of Police in 2007. The Department is composed of 350-355 members responsible for policing a geographic area over 100 square miles, and a population of 190.000 people in daily basis or 250-350.000 people in special event days. Chief mentioned a police car can cost \$24.000, because the equipment they carry in for identification. The police department has implement new technologies (e.g. nixle-text messaging) and programs (neighborhood watch) to increase the safety of the individuals and communities in their surrounding areas. According to Chief Dennis, crime decreased 7% last year by traffic enforcement, red light cameras and tactics.

He also mentioned the new communication system; it is digital, encrypted and has electronic sound. Chief Jones mentioned several times how the hams are always helpful when all the communication systems go down, he personally appreciate this help.
