License Testing



ARRL/VEC administered FCC Amateur Radio License Examinations will be provided at 7:00 p.m. on Tuesday, February 8 at the St. Francis of Assisi Episcopal Church Fellowship Hall, 3413 Old Bainbridge Road, Tallahassee. Exams will be administered for all three levels (Technician, General and Extra Class). The fee remains at \$15 this year (cash/check only). Applicants should bring a photo ID and two pencils. Calculators should have memories that can be cleared (smart phones are not advised). If you are testing for a higher class license, bring a copy of your current license with you. All applicants must also provide either an SSN or an FCC Registration Number (FRN) (available from the FCC at https://fiallfoss.fcc.gov/coresWeb/publicH

ome.do).

Get on the Air Day

On February 18th, TARS will host another of its popular Get on the Air Days. This was originally conceived as an opportunity for new hams to get on the air after receiving their new license and that is why it is usually scheduled on the second Saturday following testing. However, the event has turned into a mini-Field Day, with hams showing up with various different gear that they want to demonstrate and others showing up with guestions that need answering. Now it has turned into a "Get on the Air Day" for both new and old hams, with amateurs who have been off the air for 3-4 years often showing up to refresh their skills.

During this GOTA Day a foxhunt is being planned for participants of all ages. Details of the foxhunt will be worked out at the February TARS meeting, but we do know that it will be held as usual at the St. Francis of Assisi Episcopal Church and start around 9 a.m.

Dues

Antenna – RadioWavz PROline

Check Out These Amateur Radio Websites

Reviewing some of the handouts for the class at the end of January, I thought I better check and see if there have been any major updates to the webpages we discuss in the class. I usually have a handout on some of the more popular websites for general Amateur information, free software and any other related items which may be of interest to a new ham.



The first one that most hams think about is the **ARRL.org** from the American Radio Relay League. It was one of favorites until a few years ago when they did an "improvement". My biggest "gripe" is that things are hard to find. I usually use the "search" function to get in the area I want then play around with the drop down menus.

AC6V'S
Amateur Radio & DX Reference Guide

My all time favorite for many years has been AC6V.com. It has probably the most complete index of just about anything related to Amateur Radio. On the first page of the website they state that there 700 Topics; 6,000 Links and 133 Pages of Amateur Radio topics and information - "From Antennas to **Zones.**" There is a general topic table to give you an overview of the website's contents. Then below is a "master index & links" to the various topics. You can spend hours looking through the information or click on one of the index links to get to a specific interest area. When I last checked the webpage in early January 2012. I noticed that the last time the AC6V webpage was updated was January 19, 2010, so it may not as current as some of the others, but still has a lot of very good information in one place.



The second favorite is one of the best for both new Hams and those that have been on the air for a number of years is Hamuniverse.com. Don N4UJW, has been providing the webpage and information since 2000 and has a quote on his QRZ listing -"Ham Radio - Jest fer the fun uv it! Don takes a fairly "light hearted" approach to providing his information. The webpages and links are in a variety of colors and fonts. There is an index on the left side of the main webpage to allow you to move to the relevant topic very easily. There is quite a bit of humor in the way Don has displayed his information, but he provides a variety of topics for those interested in getting their "ticket" and those that want additional information or advice.



DXZone.com "An Amateur Radio Resource Guide" is another very comprehensive webpage that covers just about every area of

Amateur Radio. When you first open the page, you are probably surprised at the number of topics and links available. There are major headings, but you may need to put on your "bifocals" to read the small print in the link section. There is a lot of information available, just a click away. One nice thing about this webpage is that there is an "update" date in each of the sections. This lets you know that certain areas are updated more than others,but I did notice there is no "year" on the update, just the month and day. So there is no telling how current it is.



eHam.net.."Ham Radio On The Net" is another very informative webpage on Amateur Radio. The center portion of the page has links to a variety of articles submitted by Amateurs around the world. These are updated almost daily. There are also product reviews, some classified links and News mentioning Amateur Radio from around the world (movie, newspapers, TV show, etc.). There is a link in the upper right hand corner of the webpage to view earlier articles. On the left is another very well done index with just about everything you would want to investigate dealing with Ham Radio.

Proposed Amendments to TARS By-Laws

The TARS by-laws have become very out-of-date. Fortunately, Article XII states that they may be amended at any regular meeting by a majority vote, provided a written notice of the amendment is given in the newsletter distributed prior to such meeting at which the amendment is to be considered. Therefore, we are proposing some amendments in this newsletter to be considered at the February meeting. As you will see, most of the changes are very minor, just bringing the by-laws into the 21st century. You may find the complete by-laws on the TARS website at www.K4TLH.net.

Going in order through the by-laws, the first change would be in *Article I*, *Section 1.01*. *Membership*. Delete the requirement for approval of new members by a majority of members at a regular meeting. This has not been applied in years. Sentence will simply read, "Members shall be admitted upon payment of dues."

Article II, Section 2.05. Notice, states that a notice of each meeting shall be provided to each member at his address as it appears on the records of the society. We propose to change "address" to "e-mail address" because the club does not use postal mail any longer.

In Article III, Section 3.02. Regular Meeting, the order of the agenda calls for the break to occur after the committee reports. In practice, we have been having the break following the presentation and propose moving the break to that position in the order of business in the by-laws.

Article IV. Section 4.02. Dues Schedule. We propose changing the category of "Junior" to "Student."

In the same Section, we propose striking the entire sentence requiring that "Only one newsletter will be sent to each family membership." With e-mail distribution, this is no longer a problem and is often difficult to determine.

Section 4.03. Proration of Dues. We propose adding the sentence, "After December 1, dues will be applied to the next year." This will require changing the beginning of the previous sentence to read "From July 1 to November 30."

Article VIII. Section 8.02. Authorization to Incur Expenses, By Officers. We propose increasing the amount from \$50 to \$200 for immediate needs. Expenses for items such as food for Field Day are often over \$150. In addition, there is no mention of recurring expenses such as post office box, liability insurance, etc. that the treasurer must pay throughout the year. Therefore, the section will be amended to read, "The President or Vice President, or in their absence, the Treasurer and the Secretary, may authorize an expenditure of up to \$200.00 for immediate needs which must, in his or their discretion, be acted on prior to the next regular meeting. In addition, the Treasurer may pay, without prior authorization, those expenses that occur regularly throughout the year that are necessary for the functioning of the club; e.g., insurance, post office box and legal fees. All such expenditures shall be reported in the next Treasurer's report."

Article IX, Section 9.01. Remuneration. Change the last sentences to read that "such proof shall be maintained by the Treasurer." (Rather than made part of the minutes).

Article XI. Printing of the Articles of Incorporation and Bylaws. This article requires us to send a complete copy of the Articles of Incorporation and Bylaws in the newsletter for the month prior to the annual meeting in June. We propose to delete this article completely because (1) they are available on the club's website for anyone who wants to read them and (2) including them (8 pages) in the newsletter would greatly increase the size of an already large newsletter.

If Article XI is deleted, then *Article XII* and *Section 12.01* therein, will need to be renumbered as Article XI and Section 11.01, respectively.

Minutes of Previous Meeting

TARS - Tallahassee Amateur Radio Society Thursday, January 5, 2012 Meeting Minutes

7:05 PM Call to Order

Special Election: Stan, K4SBZ, began the meeting by introducing John Sample, K4ZNC, who has agreed to serve the remainder of the 2011-2012 tenure for secretary of TARS. He was elected by unanimous voice vote.

Joe Salim was introduced as a guest. He will be taking the upcoming technician class sponsored by TARS.

Officer Reports

Approval of Minutes. There were no minutes to be approved since the December meeting was a planned holiday event.

Treasurer's Report. Stan Zawrotny reviewed the treasurer's report for Larry Pusher, KI4MAJ. As of November 15, 2011, the TARS account had a balance of \$2,289, revenues of \$534 and expenses of \$156. See complete report for details.

Repeater Report. Randy Pierce, AG4UU, reported that all TARS affiliated repeaters were operating satisfactorily.

Education and Testing. Phil Ashler, KI4IPH, advised that a one-day six hour training class and prep session for the technician license will be held on January 28, 2012. According to Phil, a one-day class works better than several shorter classes spaced over time. Preparation for the class and follow-up test includes ordering and studying the ARRL Technician Class book. Alan, N4KJT, advises that a license examination will be held February 7. These events will be held at the TARS monthly meeting site. The Thomasville Amateur Radio Club (TARC) will hold its monthly test session on January 21 at the Thomas County EOC.

7:20 PM Guest Speaker: Stan Zawrotny, K4SBZ

Stan provided TARS members with an overview of Neighborhood Hamwatch, focused on its goals and benefits. Under emergency conditions, hams become the essential communication link between neighbors and friends and to city and county emergency operations. During discussion with TARS membership, Lloyd Tribley, KA2OLL, explained how he has implemented an NHW program in his neighborhood. Members discussed many issues and the extent to which NHW might be implemented locally. The discussion ended with a commitment to follow-up on a monthly basis to see if individual TARS members are having success with implementing NHW programs in their neighborhoods.

7:55 PM Break.

Tickets were sold during the break for 50/50 drawing. Members were reminded that refreshments were available and that donations to cover costs were appreciated. Stan asked if

anyone would assume responsibility for buying and setting out refreshments for TARS meetings. No one rose to the challenge, so Elizabeth, K4EAZ, will continue to provide refreshments.

8:15 PM **Open Discussion**.

Stan reminded members that the Tallahassee Marathon was scheduled for February 5. He asked if any other TARS members had been contacted. Because no one had and his email the Marathon committee had brought no response, the members decided not to provide communications for this event this year.

Stan reminded members that the Orlando HamCation was scheduled for February 10 through February 12 and he encouraged members to contact one another to carpool.

Stan reported that creating a new TARS K4TLH website was progressing well. He is working with FSU students and Melissa Raulston, webmaster and instructor in the College of Communication and Information. They will also remove the worst of the incorrect information from the current K4TLH website, remove names of members who have not paid their dues, and update the website with names of current TARS officers.

Stan inquired if members would be interested in fox hunting activities. He suggested that this could be an activity for both adults and youth interested in ham radio. This would be a good GOTA activity and Stan has asked that the TARS Youth Council provide input.

David, W4SKG, initiated a lengthy discussion regarding the status of the FEMA trailer and the TARS van. The van has a crank-up tower that can be deployed; however the van is not operable. There are recurring questions about license tags, ownership, liability, and insurance for the trailer. Randy states that Kent Hutchinson, KG4TOC, is the best source for information and he will contact Kent during January. Randy also stated that remodeling the van is not a weekend project, but will require the effort of a dedicated work party over a period of weeks or months to ready the trailer for its intended purpose.

8: 45 PM Old Business.

There was no old business.

8:45 PM New Business.

Motion by Chief, KA5USN, to increase the 50/50 drawing from \$1 to \$2 per ticket, with \$1 dollar set aside for purchase of door prizes for the next December holiday party. The motion failed for a lack of a second to the motion.

Motion by Nick, W4EAF, in lieu of the traditional March auction that TARS sponsor a hamfest/swap-meet that would require an entrance fee for tailgate sales of equipment. A second to the motion was made by Tom, K4TB. Discussion included comments that two previous hamfests generated revenue for TARS. A fee of \$5 to \$10 is a reasonable fee and that inviting members from regional ARC's would increase TARS visibility.
