

This is a fantastic way to build a shack that is completely self-sustaining in times of emergency.

#### **Announcements:**

Steve Welsh, AD4E, took a moment at the beginning of the meeting to express his gratitude to everyone for placing their confidence in him to lead TARS over the next year. His

objectives over the next year are to grow the club, and elevate the status of amateur radio in our community.

Our Leon County EC, David Davis, WA4WES, who was short of time, made an announcement that his is looking to determine the general footprint of our local repeaters. He asked that if you are traveling out of town, to try and keep an eye on the repeaters, making a note of where you are when you can no longer hear them and/or getting on the fringe of the machine. necessarily registered ARC volunteers. This would aid in making sure there are enough personnel available in the event of an emergency in our area. Kent Hutchinson, KC4TOC, mentioned that this is something that needs to be run by our new State Government Liaison, Ted Zateslo, W1XO.

Linda Miller, KG4RTX, mentioned the formation of the Ladies "Powder Puff Net," and graciously asked for the club's permission to operate the net on the 147.03 repeater. David Heupel, AG4UQ, so moved that we allow her to manage and operate her net as she sees fit on the 147.03 machine. The motion was seconded and approved.

John Love, NZ4QJ, asked that a budget committee be formed to analyze the financials of the club. The budget committee would estimate revenues, and expenditures, and deter-

mine whether or not we may need to hold fundraisers, etc. The budget committee could also propose appropriations of club funds for use on club-sponsored projects, such as putting on a training session for American Red Cross volunteers, or setting up an APRS station at a local school. Steve Welsh, AD4E, asked John if he would chair this committee, and Kent Hutchinson, KC4TOC, said he would be happy to work with John on this endeavor.

Bill Frieder, N4QNF, said he might have a line on a no-cost acquisition of a used bus, very similar to ones used by rental car companies to shuttle people from the airport to the rental car depot. Some interest was expressed in the idea. Bill agreed to look into the possibility further, and report back in the future.

Steve Welsh, AD4E, expressed interest in lowering our dues to \$15 for regular membership/ household/family and also offer a \$10 student membership. Steve believes that we might be able to grow our membership if we lower our dues. The idea generated much discussion. and no movement was made during the meeting to change our current dues structure. However, Steve asks that we give the idea some consideration over the next couple of months or so. The bottom line is that he wants to grow the organization, and make it stronger through the diversity of interests that all local amateur operators enjoy. If you have any input or feedback with respect to this issue, or how we can go about growing the club, please contact Steve Welsh by phone or email.

The meeting was adjourned at 2037 EDT.
